Basic Skills Commitments

We will provide the following services:

1. Assistance with course and curriculum selection. The PDP program advisor, after a consultation with the director and parents, will chart a course of study to be completed by each student individually.
2. Four quarterly appointments will be incorporated into scheduled PDP appointments with an expanded time frame.
3. Yearly achievement testing, covered in PDP.
4. A transcript detailing grades earned.
5. A diploma awarded at a commencement ceremony when the *Privately Developed Plan* graduation requirements are met.

Family Commitments
